### Terms of payment

Workshop deposits, 50% of total fee are due with the registration, the outstanding 50% must be paid in full before the beginning of the workshop. For registration within the four weeks before the workshop, full payment is due immediately. For any booking, please contact me before to ensure that places are still available.

### Cancellation by the participants

Cancellation at least four weeks prior to the workshop with full refund is accepted, but with an administration fee of €10,00. For cancellation up to 14 days before the start of the workshop, applicants will be entitled to a 50 percent refund. Later cancellations are subject to no refund. But the participant can suggest a replacement person.

### Cancellation by the organizers

Claudia Wiens Photography reserves the right to cancel the workshop due to extraordinary circumstances or too few participants. In this case, applicants will be given a full refund at no charge. The workshop will, if at all possible, be postponed to best suit both the organizers and original applicants. Applicants can opt to participate at the new date or choose the refund. Claims to Claudia Wiens Photography are not entitled.

### Workshop content

The organizer will endeavor to fulfill the advertised curriculum and content of the photo workshop. However, the organizer reserves the right to make minor modifications to these due to unforeseen circumstances, such as wishes of the participants or extreme weather.
